Location

Team Valley Trading Estate is recognised as the North East's Principal commercial Business Park incorporating in excess of 6.5m ft² of industrial, office and retail accommodation.

Gateshead is located to the south of Newcastle on the southerly side of the River Tyne with the Team Valley being some 3 miles distance from the city centre. Transport links are excellent as Team Valley lies just off the A1(M) which in turn links to the A19.

Team Valley is served by good public transport links namely the 91, 93 and 94 buses which operate frequently throughout the day to Gateshead and Newcastle. Newcastle Central Station provide frequent main line train services to London (Kings Cross) with a journey time of 2 hours 45 minutes and Newcastle Airport is located approximately 8 miles to the north.
