The entire property is let to Heron Foods Ltd who have been in occupation for over 30 years on a new lease dated 15th January 2024 for a term to expire on the 14th January 2034, subject to a tenant only break clause on the 14th January 2029. The current passing rent is £45,000 per annum exclusive.
