### Location

Skillion Business Centre, situated within the well-established Littleburn Industrial Estate in Moor. Durham. benefits Langley exceptionally strong transport links. The estate lies directly on the A690, which runs through Durham city and offers convenient access to the A1(M)—a mere 15-minute drive away ensuring seamless regional and national connectivity. Additionally, the A167 is just 2.1 miles away, providing efficient links to Chesterle-Street to the north and Newton Aycliffe and Darlington to the south. Nestled approximately 2 miles south-east of Durham city centre, and within comfortable reach of Sunderland to the southeast and Newcastle upon Tyne to the northwest, the centre offers an ideal base for businesses focused on industrial activity, logistics, and efficient distribution within the North East.

### **Description**

The units form part of a terrace and are of steel portal frame construction with blockwork walls. Internally the units benefit from concrete flooring, LED lighting & W.C facilities. Unit 8 also offers a kitchenette and office accommodation. Minimum eaves height to the haunch is 4.46m and maximum eaves height to the haunch is 6.32m. Ample parking is provided within the estate. The units are also equipped with roller shutter doors measuring 4.09m in height and 2.84m in width. Unit 8 features one shutter door, while Unit 5 has two.
