Location

The Unit is located at Mandale Business Park, just off the Wallsend Road, North Shields. Set within an established industrial area the premises offer excellent communication links via the A19 which lies approximately 0.3 miles away. The A19 offer access both north and south to the wider region and beyond.

Description

The property comprises an end terrace hybrid unit of steel portal frame construction with a combination of brick and blockwork infill walls, cladding to external elevations and profile sheet decking to the roof. Internally the unit comprises of a ground floor warehouse space with an office space on the first floor. The warehouse area benefits from painted concrete floor, LED lighting perfect for storage of goods. The office space is open plan with LED lighting and carpeted flooring throughout.

The unit has a roller shutter door providing access to the front, and benefits from WCs, kitchen facilities and parking.


