Location

The property is located at the entrance to Bowburn North Industrial Estate. Bowburn is situated approximately 4 miles south of Durham and 17 miles

north of Darlington at J61 A1(M). Access to the estate is off the A177.

Bowburn North is a well-established estate, with several manufacturing, logistics and trade counter occupiers in situ, including Electrolux, Esh Group and

Brakes. The estate is located immediately north of Amazon's 2m sq ft Durham fulfilment centre.

Description

The estate comprises 4 units with secure yard space. Unit 1 offers manufacturing accommodation with office space over ground and first floors.

Externally the property benefits from a secure yard to the front and rear of the buildings. Unit 1 benefits from dedicated car parking to the front of the property. The total site extends to approximately 3.91 hectares (9.65 acres).
