Location

The site is located to the rear of Linskill Terrace in North Shields, within the North Tyneside borough. It benefits from proximity to a range of local amenities, excellent public transport links, and the highly sought-after coastal area of Tynemouth.

Description

The land previously secured outline planning permission for a nine-unit apartment scheme and has a strong planning history, with several lapsed consents including proposals for two apartment blocks comprising 12 units each and a terrace of nine three-storey houses. This established planning precedent enhances the site's attractiveness and suggests that future planning consent may be more readily achievable compared with other sites in the locality.

The site comprises lapsed outlines planning permission for the development of a nine-unit apartment block with associated external landscaping and car parking. Reference **23/00708/COND** pursuant to **17/00700/OUT**.

The site benefits from lapsed planning permission for a variety of applications including the construction of 2no. block flats, each containing 12no. apartments. Reference: **09/00678/OUT** and the construction of 9no. three storey terraced townhouses with associated parking. Reference: **11/02230/OUT**.


